<b>FACTS</b>	<b>What does PARDA Federal Credit Union do with your personal information?</b>	
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all sharing. Federal law requires us to tell you how we collect, share and protect personal information. Please read this notice carefully to understand PARDA Federal Credit Union’s policy. PARDA Federal Credit Union is committed to protecting non-public, personal information. Using this information in a manner consistent with our business is a high priority.	
<b>What?</b>	<p>The type of personal information we collect and share depends on the accounts or services you have with us. The information can include:</p> <ul style="list-style-type: none"> <li>• Name, address, social security number and income</li> <li>• Account balances and transaction history</li> <li>• Credit history and credit score</li> </ul> <p>When you are no longer a member, we will not share your information, except as permitted or required by law, as described in this notice.</p>	
<b>How?</b>	All financial companies need to share member personal information to run everyday business. In the section below, we list the reasons financial companies can share their members’ personal information, the reasons PARDA Federal Credit Union chooses to share and whether or not you can limit this sharing.

<b>What We Do</b>	
How does PARDA Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with Federal law. These measures include physical safeguards such as secured files and buildings and computer safeguards. We also restrict access to personal information to those colleagues who need to know in order to provide services to our members.
How does PARDA Federal Credit Union collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>• Open an account or apply for a loan</li> <li>• Apply for any credit union product or service</li> <li>• Visit our website, provide us with information on any online application or transaction, or information you send us via email.</li> <li>• Use your debit or ATM card to pay your bills or make purchases.</li> <li>• Make deposits or withdrawals from your account.</li> </ul> <p>We also collect your personal information from others, including credit bureaus, affiliates or other companies.</p>
Why can't I limit sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>• Sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>• Affiliates from using your information to market to you.</li> <li>• Sharing for non-affiliates to market to you.</li> </ul> <p>States laws and individual companies may give you additional rights to limit sharing.</p>
<b>Definitions</b>	
Affiliates	Companies related by common ownership or control. They can be financial or non-financial companies.
Non-Affiliates	Companies not related by common ownership or control. They can be financial or non-financial companies.

Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products and services to you.
