SCHOLARSHIP GUIDELINES

Purpose:

The purpose of the scholarship is to recognize PARDA Federal Credit Union members who have shown scholastic excellence, leadership in their school and community and those who are interested in advancing their education.

Scholarship Criteria:

- Scholastic achievement
- Active participation and service to their attending school
- Active participation and service to their community

Scholarship applications should include the following:

- A completed and signed application form
- Typewritten essay, no longer than 3 pages in length.
- Copy of High school or college transcript
- Proof of acceptance to an accredited college or university (Only if you are a high school senior that is not already attending an accredited college or university.)

Complete a typewritten essay, no longer than 3 pages in length, on the following topic:

What is your favorite product or service at PARDA and why?

Qualifications:

1. Applicants must be members in good standing.
2. Each applicant must currently be an undergraduate student enrolled in an accredited college or university, or enrolled in a high school and entering an accredited college or university in the fall of the same year upon graduation from high school.
3. Applicants must have a minimum 2.5 cumulative Grade Point Average (GPA).
4. All scholarships will be issued in the name of the applicant and their attending college, unless otherwise decided by the credit union.
5. A copy of your transcript must accompany the application.
6. If a question on the application is not relevant, please explain why. Do not write N/A.
7. Essays must be typewritten and no more than 3 pages in length.
8. All walk-in applications must be received by May 31, 2017. All mail-in applications must be postmarked no later than May 31, 2017.
9. All applications received become the property of the credit union and will not be returned.
10. All applicants will be notified of the results via phone or email by June 15th, 2017.
11. Immediate family members of any employees, management, board members or committee members of the credit union are not eligible for the scholarship award.
