1. A completed and signed application form
2. Typewritten essay, no longer than 3 pages in length
3. Copy of high school or college transcript
4. Proof of acceptance to an accredited college or university
(Only if you are a high school senior that is not already attending an accredited college or university.)

Essay:

Complete a typewritten essay, no longer than 3 pages in length, on the following topic:

How can credit unions provide value and appeal to recent graduates?

Eligibility Requirements:

- Applicants must be members in good standing
- Applicants must submit a typewritten essay no longer than 3 pages in length
- Applicants must currently be an undergraduate student enrolled in an accredited college or university, or entering an accredited college or university in the fall upon graduation from high school
- Applicants must have a minimum 2.5 cumulative Grade Point Average (GPA), and provide a copy of their transcript with this application
- Applicants must demonstrate participation in service to their school and/or community
- Applications must be received or post-marked by May 31, 2019
